If your application is not actually **received** in the Secretary's office by the filing deadline (May 10 for the July exam; December 15 for the February exam), it may be deemed to be timely filed only if it has been transmitted expense prepaid to the Office of the Secretary of the Board by **Priority**, **Express**, **Registered or Certified** mail via the United States Postal Service, or by a third party commercial carrier for **Next-Day Delivery**, <u>and</u> the **official receipt** therefor issued by the United States Postal Service or by such third party commercial carrier, which shall be exhibited on demand of the Secretary, shows such transmission or mailing to the Secretary's office on or before the prescribed deadline.

**Priority, Express, Registered or Certified** mail via the United States Postal Service or **Next-Day Delivery** by a third party commercial carrier are the **ONLY** methods of transmission or mailing authorized by the statute. Thus, an application sent by any other form of mail, such as First Class mail, **CANNOT** be accepted if it is received after the filing deadline, even if it is postmarked before.

Application forms should be **filed no more than 90 days prior to the filing deadline**, but must be filed by the statutory filing deadline in accordance with § 54.1-3925 of the Code of Virginia.
